METHODS TO APPEAL

1. ONLINE FILING

Filing online allows our office to receive and process your appeal more quickly. Additionally, it alleviates your appeal being lost when using standard mail. We are excited to launch our new self-service tools which include online real and business personal property appeal filing.

Previously, we used an Appeal Resolution Center to accept appeals. Our new SmartFile system allows users to more easily track the status of their appeal. With SmartFile you can begin filing an appeal and save the transaction until you have completed answering all questions and uploaded supporting documentation or photographs. Do not click the submit button to file the appeal until you are satisfied with all of the information you have entered. Once you submit the appeal you will not be able to make any modifications or add additional documentation. After filing the appeal, you will receive a confirmation email with your filing ID number.

Select "No" for Homestead Exemption Denied. Do Not select yes if you submitted your homestead application but it is not indicated on the assessment. Denied indicates that you were actually denied, not that it may still be in process. Also, it will not let you appeal based on Value (which is what you need to do) if you select yes.

Select "Value" if you do not agree with the value of your property on the assessment. This is the most common selection. "Uniformity" refers to believing your property is incorrectly valued compared to the surrounding properties.

*Pursuant to Georgia Law, all parcels in appeal will be billed at 85% of the assessed value

listed on your assessment notice. However, you may elect to be billed at 100% of the assessed value instead. This selection must be made at the time of your appeal and will not be

You want to choose "Board of Equalization." It is free and the most commonly selected option.

You will need to indicate what you think the property is worth. I can help you determine a value to ask for.

You can choose to be billed temporarily until the appeal is resolved at 85% of the assessed value (40% of the 100%) or you can choose to pay 100% of the tax bill while the appeal is being resolved. If you can afford it, I recommend you pay 100% and if you are granted a reduction you will get a refund. If you are billed at 85% and do not win a reduction, you will be billed for the balance owed.
